

GENERAL INFORMATION

1. The building will be open at 8 a.m. with judging commencing at 9 a.m. unless entries warrant an earlier or later starting time.
2. Only dogs entered in these events will be allowed in the building.
3. Dogs will not be allowed in the building overnight.
4. Prong or Spike collars will not be permitted at this venue.
5. **Judging will proceed without any dog that is not present when called by the Ring Steward.**
6. **Handlers and exhibitors with several breeds must arrange for alternate handlers should judging times conflict.**
7. All Group judging will begin on completion of Breed judging within each group. Best In Show, Best Puppy In Show, and Reserve Best In Show will follow all Group judging. Reserve Best In Show will immediately follow Best In Show.
8. The Superintendent will be in full charge of the events.
9. The S.S.K.C. reserves the right to restrict the size and location of crates and exercise pens.
10. Judging Schedules and Identifying Cards will be mailed as soon as possible after the entries close.
11. The S.S.K.C. will use all due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume liability in the event of, an accident or any misfortune to either dogs, exhibitors, or patrons.
12. The S.S.K.C. greatly appreciates your co-operation in keeping the show building and grounds clean. Please clean up after your dogs.

ENTRY INFORMATION

- All entries must be received by the Show Secretary by the closing date and submitted on an official CKC entry form. If more forms are required, please photocopy. Include postal code and telephone number.
- Post-dated cheques will not be accepted, and all "NSF" cheques will be subject to a charge of \$25.00.
- The S.S.K.C. reserves the right to refuse any entry, subject to CKC rules.
- Exhibitors must abide by errors made in entering their dogs, regardless of how the error was made or who made it.
- Any overpayment of fees will be considered a contribution to our trophy fund.

PLEASE NOTE: A bitch in season may not compete in Obedience Trials. Entry fees will be refunded if a Veterinarian's Certificate to this effect is received by the Trial Secretary before the Trial commencement.

ADVERTISING: Full page: \$30.00; ½ page: \$15.00. All copy must be ready for printing and received by the Show Secretary prior to the closing date.

BOOTH SPACE: Limited. Weekend: \$40.00. Must be pre-booked and pre-paid by May 14.

A class dog awarded Best In Show at an All Breed Championship Dog Show will be credited with five points inclusive of any points won at the Breed or Group level. In no case may a dog earn more than FIVE points at a single show.
